

## **Spring Equinox Liability and Publicity Waiver:**

***I understand that by registering electronically, I accept and agree to the waiver and release agreement presented in the online registration and that this document includes a release of liability and waiver of legal rights that deprive me of the right to sue certain parties. By agreeing electronically, I acknowledge that I have read and understand the release agreement presented to me as part of the online registration process.***

I know that running a road race is a potentially hazardous activity. I should not enter and run unless I am medically able to do so and properly trained. I assume all risks associated with running in this event including, but not limited to: falls, contact with other participants, inclement weather, traffic, course conditions and markings, all such risks being known and understood by me. I am aware that volunteer personnel (who may be called upon to provide assistance) may provide medical support for this event, including first aid. I authorize any such volunteer to assist me or to perform such assistance as in the opinion of such person may be appropriate. I understand that the Equinox Half Marathon and 4 Mile Races, Green Events LLC, Green Events Inc., City of Fort Collins, Larimer County, State of Colorado, Anheuser-Busch, the race directors, event staff, volunteers or anyone else involved with this race assumes no responsibility or liability with respect to my participation in this event. I agree, however, to abide by any decision of any race official relative to my ability to safely complete the run. I hereby grant permission to Green Events LLC, Green Events Inc. and the Equinox Half Marathon & 4 Mile race and its sponsors to use any photographs, motion pictures, recordings or any record of this event for legitimate purposes. I agree to abide by the rules of this race as stated in all official race information. Having read this waiver and knowing these facts and in consideration of your accepting my entry, I, myself and anyone entitled to action on my behalf do hereby release and discharge the Equinox Half Marathon & 4 Mile Races, Green Events LLC, Green Events Inc., City of Fort Collins, Larimer County, State of Colorado, Anheuser-Busch, and all event coordinators, event staff, volunteers, all sponsors, representatives (including event volunteers), and employees of any of them, from any and all claims or liability of any kind arising out of my participation in this event, even though that liability may arise out of negligence or carelessness on the part of persons or entities named in this waiver. For the safety and consideration of other participants, please follow these guidelines: Yield to faster runners and walkers; No roller blades, in-line skates, scooters, bikes or skateboards on the course; Please don't wear headsets or ear buds. I understand I must complete the course in the specified time and that anything longer than that duration will require me to be picked up by an event sag vehicle or to become a pedestrian by my own choosing.

I know that running in an event that is organized as a virtual activity where I run on my own, at a date and time of my choosing, in a location and running route of my choosing, which will not have any support or security measures in place by Green Events LLC is a potentially hazardous activity, which could result in injury or death. I acknowledge that I am participating in the activity outlined by this virtual event by my own free will and at my own personal risk. I will not participate in a virtual event unless I am medically able and properly trained, and by my signature, I certify that I am medically able to perform this event, and am in good health, and I am properly trained. I assume all risks to me associated with running on my own as part of this virtual activity, including but not limited to: falls, contact with other pedestrians, the effects of

the weather, including high heat and/or humidity, traffic and the conditions of the road or trail, all such risks being known or unknown and appreciated by me when out running on my own without any type of support from local officials or event organizers.

I understand that there are NO REFUNDS. I further understand and agree that there will be no refunds, under any circumstances, including but not limited to injury, a scheduling conflict, Acts of God (including fire, flood, earthquake, storm, hurricane or other natural disaster) and/or event cancellation. I understand if the in-person event is cancelled for any reason, the event will become a virtual event and that there will be no refunds.
